

## Sweepstakes Official Rules

4. Open to legal residents of the State of New York 18 years of age or older at time of entry. Employees of Buffalo Bills, LLC, the National Football League, and the affiliates, subsidiaries, advertising, promotion, and fulfillment agencies, and members of the immediate family or household of each of the foregoing are not eligible to participate.
5. **HOW TO ENTER.** To enter, follow the instructions to complete the form on the official My One Buffalo mobile application during the Sweepstakes Period stated in Rule No. 2. Entrant must abide My One Buffalo mobile app rules, terms, and conditions. The official My One Buffalo mobile application is free to download and register on your smartphone.
